

Attention Providers,

This notification is to inform Providers required to use Electronic Visit Verification (EVV) for Home Health Services (HHS) being billed on an institutional (837i) claim that training materials and configuration options for the changes to Home Health Services 837i Claims are now available. As a reminder, each Iowa HHS provider must set these configuration options no later than **October 1, 2024**.

At the direction of Iowa Medicaid, and in collaboration with Iowa Total Care, Molina Healthcare of Iowa, and Wellpoint Iowa, CareBridge has made enhancements to the claiming process, in response to provider feedback.

Changes to Home Health Services 837i Claim Elements

As previously announced, Iowa Medicaid, Iowa Total Care, Molina Healthcare of Iowa, Wellpoint Iowa, and CareBridge have aligned on changes that will allow providers the flexibility to set static or dynamic values for the following data fields, which were previously pre-populated or not included on claims bill through CareBridge:

- **Attending Provider**
- **Referring Provider**
- **Facility Type Code**
- **Claim Frequency Code for Initial Claims**
- **Patient Status Code**
- **Admission Date/Patient Certification**
- **Condition Codes**
- **Value Code**

Documentation and Training Resources

To assist providers in preparing for these updates, comprehensive training materials and setup options are available on the CareBridge EVV Training & Resource Site as well as directly within the CareBridge EVV Provider portal for all providers. To avoid billing alerts related to this change, all providers must take action within the CareBridge EVV Provider portal prior to **October 1, 2024**.

Providers must set up their claim elements in the CareBridge EVV Provider portal. This flexibility allows providers to set static or dynamic values for the claim data fields listed above.
