Good afternoon,

The Wyoming Department of Health (WDH) has contracted with CareBridge to provide the required Electronic Visit Verification (EVV) system to Wyoming waiver providers at no cost.

You are receiving this message because CareBridge has not heard from your organization regarding its decision on which EVV system you will use. Please keep in mind that if you do not choose to use the free CareBridge EVV system, you must obtain approval from the Wyoming Department of Health (WDH) to use another EVV system at your organization's expense. If you plan to use another EVV vendor, they must be compliant with the *21st Century Cures Act* and able to integrate effectively with the CareBridge EVV solution within the timeline outlined below.

It is critical that your organization make a decision no later than December 1, 2021 to ensure adequate time to become familiar with the CareBridge EVV system or to give your alternate EVV vendor time to complete the necessary integration activities. It is important that your visit and billing data integrate with CareBridge to ensure that your organization's service claims, as listed below, will continue to be paid after February 28, 2022.

Effective March 1, 2022, the following services will require EVV data for claims payment:

If you do not indicate your decision to use another EVV Vendor by December 1, 2021, your organization will be required to use the CareBridge EVV system until your vendor can be integrated with the CareBridge Solution.
