

# Home and Community Based Services

Good Morning,

The Wyoming Department of Health, Division of Healthcare Financing (Division) is pleased to announce that EVV is now live!

Electronic Visit Verification (EVV) is a federal requirement of the 21st Century Cures Act, which outlines the system requirements for compliance and uses technology to electronically capture information about when and where home and community-based services (HCBS) of the Medicaid waivers begin and end.

We encourage you to begin using EVV now to ensure adequate time for your organization to prepare for this change. CareBridge is offering both live and recorded training as early as today. Being familiar with the EVV system's functionality will ensure you are fully operational by the implementation deadline so your organization does not experience a disruption in claims reimbursement.

Providers of the HCBS services listed below will be required to be utilizing EVV to document visits no later than March 31, 2022. Any claims for these services generated and submitted outside of the CareBridge EVV system beginning April 1, 2022 will be denied for payment.

If you chose not to use the CareBridge EVV system, which is being offered for HCBS Waiver Providers to use free of charge, and you opt to use your Organization's existing EVV system or purchase one at your Organization's expense, you must work with CareBridge to verify that the system your organization has chosen meets compliance with the *21st Century Cures Act* and is able to integrate effectively with the CareBridge EVV solution in order to submit claims and aggregate EVV data.
